## Recent changes and benefits of **Qualified Charitable Distributions**

The new Secure Act 2.0, enacted last December, made interesting changes that affect retirement planning and giving. The age for required minimum distributions (RMDs) went up to 73 for most of us.

The Act also created a couple of new important charitable planning opportunities - I'd like to focus on one. The Act expands the definition of Qualified Charitable Distributions to allow one-time distributions to create life income plans, specifically Charitable Gift Annuities (CGAs) and Charitable Remainder Trusts (CRTs) Hang with me here - there are a lot of details to consider - I am just hitting the highlights in this brief overview.

This new type of QCD is a one-time maximum transfer of \$50,000 to a qualified CRT, or CGA. This special withdrawal and transfer can only be done once during the lifetime of an IRA owner. Other important rules apply to the new QCD for life income plans:



- The QCD to a life income plan does not qualify for an income tax charitable deduction. But, you are not taxed on the QCD withdrawal
- The transfer is one-time only, up to \$50,000, and only in a single year
- A spouse can also transfer up to \$50,000 under the same rules, in any year they choose.

If you are considering a gift but have a need for income for life, a Charitable Gift Annuity or Trust has long offered a tax-leveraged way to give. The new regulations imposed starting this year can be a real advantage if you are required to make annual minimum distributions and may not need the income for current expenses.
