## **Estate Planning Overview**

#### **Last Will & Testament**

- Disposition of your property (home, bank, accounts, household items) after your death
- Choose who inherits, what they inherit, and name personal representative in charge of administering
- Without a Will, Indiana Law of intestacy determines who inherits from estate
- To be valid, a Will must be signed by you and signed by two disinterested witnesses who watch you sign and watch each other sign

### **Financial Power of Attorney**

- Appoint the person(s) who should manage your finances if you are unable to do so
- Choose someone who you trust for this position
- Can take effect immediately upon signing or only when your doctor determines incapacity exists
- It must be signed in the presence of a notary public

#### Healthcare Power of Attorney/Advance Directive

- Appoint the person(s) who should make your healthcare decisions if you are unable to do so
- Recent changes in the law expand what can be included in Healthcare POA/Advance Directive
- Choose someone who you trust for this position

#### Can take effect immediately upon signing or only when your doctor determines you are incapacitated

- Speak to doctor if interested in DNR/POST forms
- It must be signed in the presence of a notary public

#### Without Estate Planning

- Without a Will the law of intestate succession determines who inherits from the estate
- Without a financial power of attorney or healthcare directive, it may be necessary for a family member or friend to petition the court for guardianship. A quardianship is much more expensive and timeconsuming process than appointing an attorney and healthcare representative



You should consult with an attorney to prepare an estate plan that fits your specific circumstances.


